# Huntingdon Drama Club – AGM – 23/02/2005

- 1) Apologies Trish James, Lynda Savory, Maggie Redgrave, Rachel Greaves and Roger Trencher
- 2) Minutes of last AGM Distributed and agreed
- 3) Matters Arising None
- 4) Chairs Report Attached
- 5) **Secretary's Report** This was predominantly covered during the Chair's report, RL extended his thanks to those who had worked towards putting on the productions over the past year.
- 6) Treasurers Report attached. Proposed as an accurate report by RM, seconded by Jeanette.
- 7) Draft Constitution MB distributed the draft constitution outlining main changes. First was the change of the financial year and the removal of the acting fee. The draft also specified the creation of a new position on the committee, the vice-chair, to assist the chair and to hold meetings in the chair's absence, the removal of the role of Associate Member was also to be scrapped. EW suggested that any committee member should have been a member of the club for at least a year. VG suggested narrowing this down to only the officers. Draft Constitution proposed by DW, seconded AW.
- 8) Election of Officers Chair EW nominated MB, seconded by JM
  Vice Chair MB nominated RO, Seconded by RM.
  Secretary RO nominated RL, Seconded by AW
  Treasurer JM proposed RS, Seconded by RO
- 9) Other Committee members RO nominated JM, RM seconded AW nominated PW, RM seconded RM nominated KA, Annette seconded EW nominated ML, RO seconded
- 10) **Huntingdon Youth Theatre Representative** DW announced that RL would be representing the Youth Theatre as their representative.
- 11) Auditor for financial report To be determined independently by the committee
- 12) HYT Report DW reported that HYT has a leadership up to 12 now, with 50 members and a further waiting list of 12. Regretfully the HYT have had to sever their links with the PAC at Hinchingbrooke following the performance of "Return to the Forbidden Planet". Aside from this major performance HYT had produced 4 nights of one act plays. Currently planned for the new year were a small group to perform a dance routine for a charity function, a stage adaptation of Terry Pratchet's "The Fifth Elephant" and "Murder on the Nile", the latter two to be performed at the Commemoration Hall.
- Subscriptions for 2005 Subscription fees to remain at £10 per annum. Proposed by DW seconded by VG.
- 14) Activities planned for 2005 Spring Production to be "Fallen Angels" by Noel Coward. LS & VG had prior agreed to carry out a workshop or two throughout the oncoming year. Finally RS suggested a "Mummers Play" and explained the background of the style. Perhaps to be performed

as part of the Huntingdon 800 celebrations. VG proposed these could also be performed at a festival in Peterborough for the end of June.

15) AOB – EW presented a message regarding the changes made to the committee and how no EGM was called. MB explained that there is no EGM advised in the constitution and accepts it could have been done differently; however at the time the committee acted to deal with difficulties as they deemed most likely to be effective. EW suggested liaising with the membership more frequently should these situations arise again, and this was agreed.

It was decided a card be sent to Roger and Rachel as a thank you for their work over the years and later a card for their wedding. Proposed by DW, seconded by RM.



#### CHAIR'S REPORT ON 2004

#### Productions

- Spring: *May-hem*: two one-act plays were directed by Lynda Savory. Food was served on Saturday night. The production made a profit.
- Autumn: as Ruth Morgan was unable to cast You can't take it with you, she organised a variety show, Bobby Dazzler, in aid of the Mayor of Huntingdon's charities. It raised nearly £850.

#### Newsletters

• These were produced in March, April, July, September, November and December. Other emails were also sent to members and supporters, including notification of the AGM and other events.

#### **Social events**

- A members' night was held in March.
- A trip to the RSC in Stratford, planned for November, was cancelled owing to lack of support.
- A dinner was held at the Marriott Hotel in November.
- A social evening and viewing of *You can't take it with you* took place in January 2005.

#### Various

- **Archives**: Iris Boatfield has catalogued these, and they are currently in Michael Black's house.
- **Database of contacts**: Rachael Orchard has brought this up to date. Newsletters are sent (by email as far as possible) to everyone interested, whether or not they are members.
- Website: John Morgan and Ray Livermore have set up a new website.
- **Market Inn quizzes**: the committee has continued to provide questions every month.

#### Committee

- Of the 8 committee members elected at the last AGM, 5 left during the year, for a variety of reasons, and 3 others (John Morgan, Ronald Stevenson, Rachel Greaves) were co-opted.
- The last AGM decided that the committee should elect a Vice-Chair, and Michael Black was chosen.

#### Constitution

- The revision of the Constitution was completed. Following a decision made at the last AGM, the acting fee was dropped.
- A recommendation was made to have only full membership.

#### The Future

- **Spring production**: as the Committee took responsibility for poor publicity of the auditions in 2004, the play was held over until spring 2005. However, it still proved impossible to cast, and so *Fallen Angels* (by Noël Coward) was chosen instead, to be directed by Michael Black. Performances May 19-21.
- **Workshops**: Lynda Savory and Valerie Gerrard have agreed to run a workshop, on a date to be arranged.
- **Mummers Play**: a mummers play is planned, for possible performances on St George's Day and in the Huntingdon 800 community play in July/August.
