

# **Minutes of Committee Meeting**

Thursday, 28 November 2013, 7.30 pm 28 Huntingdon Road, Brampton

1 Apologies: Phil Green, Rebecca Hutchison, Scott Hutchison

2 Minutes of last meeting (17 October 2013): accepted.

**3 Matters arising:** re 3, Financial report: the bank signatories are now BP, CM, MB and Ann Monk. [Confirmation of the change has been received from the bank since the meeting.]

**4 Financial report:** bank balance as per statement of 31 Oct: £2,451.16. A number of payments in and out have since been made or will be made. The profit on the autumn production is expected to be £95.69. [*Revised to* £70.69 since the meeting.]

**5** Autumn production (*Picasso at the Lapin Agile*): VG (director) and JM (producer) were both very satisfied with the success of the production, and praised the hard work of the cast and of the backstage and front of house helpers. It was agreed that having the prompter attending from early in the rehearsal period was extremely helpful. Ticket sales (including complimentaries) amounted to 210 (32, 111 and 67 respectively for the three performances).

6 Spring Production (20-22 March): Steph Hamer has submitted Alan Bennett's comedy *Habeas Corpus*. MB briefly described the plot, cast, set and props. It was thought likely that the play could be cast, and would attract audiences. The submission was accepted. JM to contact Steph. It was agreed that the bar should be open between the end of the Saturday night performance and the beginning of the after-show party.

**7 Constitution: proposed revision for presentation to AGM:** possible changes to the constitution were discussed, including proposals presented by BP. BP to make a final version for the AGM. The main changes include the removal of references to assistance to charities, Honorary members and lapsed membership, and the inclusion of a statement that the Vice-Chair is to

be elected by the committee from among their own number, at the first meeting after the AGM.

### 8 Reports on activities:

a. Alconbury working day (27 Oct): JM, CM, BP, Ann Monk and Les Bosworth successfully sorted the contents of our store, and made them far more accessible.

b. Play reading (8 Nov): this was organised by CM, and although only a handful of people attended, it was a highly enjoyable evening. Some concern was expressed that the main targets of the play readings – people not involved in rehearsals – are not attending.

#### 9 Future Activities:

a. Play reading: Steph has said that if *Habeas Corpus* was accepted, she would like to have a reading of it in December, prior to auditions in early January. This was agreed. JM and BP to organise a venue, JC to publicise.
